Interpreting the equal protection clause of the Fourteenth  
Amendment, the Supreme Court has generally subjected

#### **Ambach v. Norwick - Joel Dufresne Case - Google**

(a) As a general principle, some state functions are so bound up with the operation of the State as a governmental entity as to permit exclusion from those functions of all persons who have not become part of the process of self-government.

#### **Ambach v. Norwick | Casebriefs - Part 2**

Discussion: *Norwick* extends the rational basis test to more tangential areas of government function. Under the majority's reasoning in *Norwick*, there is no clear horizon to a State's ability to discriminate against legal aliens as government employees.

#### **Ambach v. Norwick Case Brief - Quimbee**

*Norwick* and *Dachinger* filed suit against *Ambach* (defendant) in federal district court on the grounds that 3001(3) violated the Equal Protection Clause of the Constitution. The district court held the statute was unconstitutional due to its over-breadth, and *Ambach* appealed to the United States Supreme Court.

Important Paras. Over time, the Court's decisions gradually have restricted the activities from which States are free to exclude aliens. The first sign that the Court would question the constitutionality of discrimination against aliens even in areas affected with a "public interest" appeared in *Oyama v.*
