A conviction for conspiring to bribe a state official based on such surveillance was set aside because the statute did not meet fourth amendment requirements: (1) it did not require the police to describe in detail

Berger appealed the decision of the New York Court to the Supreme Court based on the protections of the Fourth Amendment. The Supreme Court found the New York statute to be too broad and reversed the ruling against Berger.

We have concluded that the language of New York's statute is too broad in its sweep, resulting in a trespassory intrusion into a constitutionally protected area, and is, therefore, violative of the Fourth and Fourteenth Amendments.
