The case was decided a year after the court held in Gideon v. Wainwright that indigent criminal defendants had a right to be provided counsel at trial.

I would affirm the judgment of the Supreme Court of Illinois on the basis of *Cicenia v. Lagay*, 357 U.S. 504, [p493] decided by this Court only six years ago. Like my Brother WHITE, post, p. 495, I think the rule announced today is most ill-conceived, and that it seriously and unjustifiably fetters perfectly legitimate methods of criminal law enforcement.
