WILLIAMS 322 U.S. 4 (1944)A Florida statute made the failure to perform services according to an agreement (for which an advance had been made) prima facie evidence of an intent to defraud. The Supreme Court, in an opinion by Justice robert h. jackson, voided the statute, 7-2, as a violation of the thirteenth amendment and of the Anti-Peonage Act of 1867.
