Welsh refused to appear for induction and, on June 1, 1966, was sentenced to three years imprisonment. The Court ruled in *United States v. Seeger* (1965) that conscientious objector status was not reserved to individuals of a traditional religious background.

Welsh v. United States Case Brief - Quimbee

Welsh did state that he had a conscientious objection to participating in a war in which people were killed, because he believed the taking of any life to be wrong. Welsh also stated that he would prefer to go to jail than serve in the army. Welsh was convicted and sentenced to imprisonment. The court of appeals affirmed the conviction, and the United States Supreme Court granted certiorari.
